The derived return and NOC functions allow customers to select an item received within the past 60 business days, enter the required return reason code or NOC code, obtain the reference number of the return or NOC transaction, and print or download a copy of the derived item.

Available via the FedLine Web<sup>®</sup> or FedLine Advantage Solutions, FedACH Risk Management Services provide depository financial institutions with tools to help mitigate ACH risk.

#### FedACH Risk Origination Monitoring Service

Control ACH payments originated by your customers regardless of the network entry point or ACH software.

- Originating depository financial institutions (ODFIs) can monitor ACH batches with selected routing transit numbers and company IDs
- Self-administer monitoring criteria. Monitoring is performed at the batch level and can be based on either a single processing day or multiple exposure days.

#### FedACH Risk RDFI Alert Service

- Proactively manage potential risks as a receiving depository financial institution (RDFI) and provide ACH information to your receivers
- Obtain information-only notice of unusual or noteworthy conditions within an RDFI's incoming FedACH batches/files and/or within the receiver's items

#### FedACH Risk Returns Reporting Service

- ODFIs can identify potential ACH fraud or problem accounts
- Obtain reports listing returns, whether unauthorized or administrative, for any originator with even a single return for a single day or for a range of up to 10 processing days within the previous 60 business days

#### FedACH SameDay Service

Accomplishes processing, editing, distribution and settlement of virtually any ACH payment during the current processing day as provided for by the ACH Rules.

Available via FedLine Web or FedLine Advantage, the FedPayments Reporter Service for FedACH enables you to automatically search ACH transactions for ACH information, convert the data into human-readable reports and machine-readable files, and distribute the information within your institution or directly to your business customers.

- Generate reports automatically on a fixed schedule or request reports "on demand"
- Provide payment remittance detail to your customers including health care providers
- Receive reports in assorted file formats of your choice
- Receive automated email notifications
- Retrieve reports via an encrypted email portal
- Send reports to a FedLine Solution to facilitate population of online banking sites
